

SERVIZI FINANZIARI

LA COMMISSIONE PROPONE NORME PER RAFFORZARE LA TUTELA E LA FIDUCIA DEI CONSUMATORI NEI SERVIZI FINANZIARI

Per creare un sistema finanziario più sicuro e più sano, prevenire future crisi e ripristinare la fiducia dei consumatori, la Commissione ha proposto misure per garantire in tutta l'UE un livello di protezione equo e completo dei consumatori dei servizi finanziari. I titolari di depositi bancari potranno ad esempio ottenere dalla loro banca una restituzione più rapida dei loro fondi (entro 7 giorni), un aumento della copertura (fino a 100 000 euro) nonché maggiori informazioni sulle modalità di funzionamento della protezione a loro favore. Gli investitori potranno godere di maggiore protezione e indennizzi più rapidi in caso di frode, negligenza o errori. Anche per i titolari di polizze assicurative sarà introdotta una protezione contro il rischio di inadempienza della compagnia assicuratrice. Le proposte in questione, perfettamente coerenti con gli impegni presi dall'UE nell'ambito del G20, sono ora trasmesse al Parlamento europeo e al Consiglio per essere esaminate.

Il commissario per il Mercato interno e i servizi Michel Barnier ha dichiarato: "L'adozione del pacchetto odierno rappresenta l'ultimo contributo della Commissione per apportare trasparenza e responsabilità al sistema finanziario europeo e per prevenire o gestire future crisi. I consumatori europei meritano di più: devono poter essere sicuri che i loro risparmi, investimenti o polizze assicurative siano protetti indipendentemente dal paese dell'UE in cui vivono. Perché questo diventi una realtà, invito quindi il Parlamento europeo e il Consiglio a procedere rapidamente nell'approvazione del pacchetto presentato oggi."

La protezione dei vostri risparmi

La recente crisi finanziaria ha dimostrato ancora una volta in che misura le banche siano esposte al rischio di "assalto allo sportello", ossia ciò che avviene quando i clienti di una banca ritengono che i loro depositi non siano più sicuri e si presentano allo sportello per ritirarli tutti contemporaneamente. Dal 1994 una direttiva (94/19/CE) prevede che tutti gli Stati membri dispongano di una rete di sicurezza per i titolari di depositi bancari. Se una banca viene chiusa, i sistemi nazionali di garanzia dei depositi devono rimborsare i titolari dei conti fino ad un determinato livello di garanzia.

Quando nel 2008 è scoppiata la crisi finanziaria, sono state apportate alcune modifiche correttive d'urgenza, in particolare per portare il livello della garanzia a 100 000 euro (in due fasi) e eliminare la possibilità della coassicurazione (cioè quando i titolari dei conti non vengono rimborsati integralmente, ma devono sostenere una determinata percentuale di perdita, anche quando la somma persa è inferiore al limite di garanzia). Dato però che sono state rinvenute altre lacune nei sistemi attualmente in vigore, la Commissione ha deciso di presentare una proposta per modificare integralmente la direttiva del 1994 e tenere pienamente conto degli insegnamenti tratti dalla recente crisi.

Gli elementi fondamentali della proposta sono i seguenti:

- **Una maggiore copertura:** l'aumento della garanzia a 100 000 euro entro la fine di quest'anno è stato confermato. Questo significa che il 95% dei depositanti bancari nell'UE recupererà i propri risparmi se la banca fallisce. La garanzia riguarda ora le piccole, medie e grandi imprese nonché tutte le valute. Sono esclusi tutti i depositi di istituzioni finanziarie ed enti pubblici, i prodotti di investimento strutturati e i certificati di debito.

- **Pagamenti più rapidi** : i titolari di depositi bancari saranno rimborsati entro sette giorni.Questo rappresenta un notevole miglioramento in quanto oggi molti titolari di depositi devono attendere settimane, se non mesi, prima di poter recuperare i propri fondi.Per facilitare la rapidità dei pagamenti, i gestori dei Sistemi di garanzia dei depositi dovranno essere informati con un certo anticipo dalle autorità di vigilanza in merito a eventuali problemi incontrati dalle banche.Queste ultime dovranno specificare nei loro registri contabili se i depositi sono protetti o meno.

- **Semplificazione delle formalità amministrative**: ad esempio, una persona che vive in Portogallo e ha un conto presso una banca in fallimento la cui sede centrale è in Svezia, verrà rimborsata automaticamente dal sistema portoghese che fungerà da punto di contatto.Il sistema svedese provvederà poi a rimborsare il sistema portoghese.Ciò costituirebbe un notevole miglioramento rispetto alla situazione attuale, dove tutta la corrispondenza deve avvenire attraverso il sistema del paese nel quale ha sede la banca in questione.Questa nuova impostazione comporterà minori adempimenti burocratici e pagamenti più rapidi.

- **Maggiori informazioni** :i titolari di depositi bancari saranno maggiormente informati in merito alla copertura e al funzionamento del loro sistema attraverso una nuova scheda standard facilmente comprensibile e tramite i loro estratti conto.

- **Finanziamenti responsabili a lungo termine** :sono state espresse delle preoccupazioni in merito al finanziamento degli attuali sistemi di garanzia dei depositi. Le proposte odiere ne garantiscono una maggiore solidità finanziaria grazie ad una procedura in quattro fasi.Anzitutto, un importante finanziamento anticipato permette la costituzione di una solida riserva.In secondo luogo, se necessario, sono possibili integrazioni mediante contributi aggiuntivi successivi.In terzo luogo, se ciò non sia ancora sufficiente, i sistemi possono prendere a prestito importi limitati da altri sistemi di garanzia ("prestati reciproci").In quarto luogo, come ultima istanza, possono essere conclusi altri accordi di finanziamento in caso di necessità.I contributi, come avviene attualmente, saranno effettuati dalle banche.Essi saranno però calcolati in modo più equo in quanto saranno proporzionali al rischio costituito dalle singole banche.

Non solo i cittadini europei beneficeranno di una maggiore protezione dei loro depositi, ma potranno anche scegliere i migliori prodotti di risparmio in qualsiasi Stato dell'UE senza doversi preoccupare di eventuali differenze nel livello di protezione.Le banche trarranno vantaggi da questa proposta in quanto potranno offrire prodotti competitivi in tutta l'UE senza essere ostacolati da tali differenze.Inoltre i contribuenti beneficeranno di un migliore finanziamento dei sistemi in quanto solo di rado saranno necessari interventi statali.

La maggior parte di queste misure potrebbero entrare in vigore entro il 2012 o il 2013 e verranno applicate in tutti gli Stati membri dell'UE, nonché, una volta integrate nell'accordo sullo Spazio economico europeo, in Norvegia, Islanda e Liechtenstein.

La protezione degli investimenti

Dal 1997 la direttiva relativa ai sistemi di indennizzo degli investitori (97/9/CE) ha tutelato gli investitori che utilizzano servizi di investimento in Europa prevedendo forme di indennizzo qualora una società di investimento non sia in grado di restituire le attività appartenenti ad un investitore.Ciò può verificarsi, ad esempio, in caso di frode o negligenza colposa da parte di una società o di errori o problemi nei suoi sistemi.Non si tratta di una protezione nei confronti del rischio di investimento in quanto tale.Esistono attualmente 39 sistemi di indennizzo degli investitori nei 27 Stati membri dell'UE.

Negli ultimi anni la Commissione ha ricevuto numerose denunce in merito all'applicazione della direttiva in alcuni Stati membri.Tali denunce riguardavano sistemi che non disponevano di fondi sufficienti per liquidare le richieste di indennizzo o i lunghi tempi di attesa necessari per ottenere un indennizzo.

La proposta odierna mira a garantire che le norme sulla tutela degli investitori siano più efficienti, che vi sia una parità di condizioni per quanto riguarda il tipo di strumenti finanziari tutelati, che la dotazione finanziaria sia adeguata e che vengano prese le disposizioni necessarie affinché gli investitori siano indennizzati.

Gli elementi fondamentali della proposta sono i seguenti:

- **Una maggiore copertura**: il livello minimo di indennizzo attuale per gli investitori è di 20 000 euro. La proposta della Commissione prevede che esso venga portato a 50 000 euro per investitore.

- **Pagamenti più rapidi**: nell'ambito della legislazione vigente gli investitori rischiano di dover attendere persino diversi anni prima di ottenere un indennizzo. Questa situazione è destinata a cambiare con la proposta della Commissione che prevede che gli investitori siano indennizzati al più tardi entro 9 mesi dal fallimento della società di investimento. Tale lasso di tempo è infatti necessario per consentire alle autorità competenti di effettuare le necessarie indagini sul caso e definire la situazione dei singoli investitori.

- **Maggiori informazioni**: gli investitori riceveranno informazioni più chiare e approfondite in merito al livello di tutela delle loro attività. Ad esempio: il rischio di investimento, cioè un investimento che perde valore a causa del calo del mercato azionario o del fallimento di un emittente, non è tutelato dalla direttiva.

- **Finanziamenti responsabili a lungo termine**: dal 1997 in vari Stati membri si è verificata una serie di casi in cui i sistemi non disponevano di fondi adeguati per indennizzare la perdita di attività subita dagli investitori. Nella sua proposta, la Commissione fissa un livello minimo "obiettivo" di dotazione finanziaria che deve essere integralmente prefinanziato. In caso di necessità, i sistemi di garanzia possono prendere a prestito un importo limitato da altri sistemi e attraverso altre fonti di finanziamento come ultima istanza ("prestiti reciproci"). Tali contributi devono essere effettuati dalle società di investimento.

- **Una maggiore protezione**: attualmente, gli investitori non sono sempre tutelati se la società di investimento ricorre ad un terzo fiduciario per custodire le attività del cliente e tale terzo fallisce senza restituire le attività investite. Analogamente, i sottoscrittori di fondi di investimento possono subire una perdita in caso di fallimento di un fiduciario o di un sub-depositario del fondo. Il caso della frode del fondo Madoff nel 2008 ne è un recente esempio. La Commissione propone ora di tutelare anche queste situazioni.

La maggior parte di queste misure potrebbero entrare in vigore entro il 2012 o il 2013 e verranno applicate in tutti gli Stati membri dell'UE, nonché, una volta integrate nell'accordo sullo Spazio economico europeo, in Norvegia, Islanda e Liechtenstein.

Migliorare la tutela dei titolari di polizze assicurative

I sistemi di garanzia degli assicurati costituiscono la protezione di ultima istanza dei consumatori quando le compagnie di assicurazione non sono in grado di onorare i loro impegni contrattuali, offrendo una protezione contro il rischio di inadempienza qualora una compagnia assicuratrice cessi l'attività.

I sistemi di garanzia degli assicurati possono offrire una protezione versando un indennizzo ai consumatori o garantendo la validità del contratto di assicurazione, ad esempio, agevolando il trasferimento delle polizze ad un assicuratore solvibile o al sistema di garanzia stesso. Contrariamente a quanto avviene per i settori delle banche e dei valori mobiliari, non esiste attualmente una normativa europea sui sistemi di garanzia nel settore delle assicurazioni. Attualmente 12 Stati membri gestiscono uno o più sistemi di garanzia degli assicurati che coprono polizze del ramo vita e/o non vita. Il livello di protezione e i criteri di ammissibilità, nonché le modalità di intervento o di finanziamento, variano da un sistema all'altro.

Nel Libro Bianco che è stato adottato oggi, la Commissione illustra diverse possibilità per garantire nell'UE un livello di protezione dei consumatori equo e completo, nonché per evitare che i contribuenti debbano pagare di tasca propria in caso di fallimento di una compagnia di assicurazioni. In particolare propone di adottare una

direttiva per fare in modo che tutti gli Stati membri istituiscano dei sistemi di garanzia degli assicurati che ottemperino a una serie minima di requisiti. Il Libro Bianco sui sistemi di garanzia degli assicurati è presentato alla consultazione pubblica e tutte le parti interessate sono invitate a trasmettere le proprie osservazioni o i propri contributi entro il 30 novembre 2010.

AFFARI ECONOMICI E MONETARI

L'UE APRE UN DIBATTITO PUBBLICO SUL FUTURO DELLE PENSIONI

La Commissione europea apre oggi (fino al 15 novembre) una consultazione pubblica a livello europeo sui modi per garantire pensioni adeguate, sostenibili e sicure e sulle migliori possibilità che ha l'UE di sostenere gli sforzi nazionali in questo senso. L'invecchiamento della popolazione in tutti gli Stati membri ha posto i sistemi pensionistici esistenti sotto un'enorme pressione, accentuata dalla crisi economica e finanziaria. Il documento di consultazione, un Libro verde, pone una serie di domande e invita tutte le parti interessate a comunicare osservazioni, opinioni e idee per affrontare il problema delle.

Presentando il documento di consultazione, con il pieno appoggio dei commissari Olli Rehn (Affari economici e monetari) e Michel Barnier (Mercato interno e servizi), László Andor, commissario UE per l'Occupazione, gli affari sociali e l'integrazione ha dichiarato:

"Entro il 2060 si prevede che il numero di pensionati in Europa raddoppi rispetto a quello di quanti finanziano le loro pensioni - la situazione attuale è semplicemente insostenibile. Nell'affrontare tale sfida occorre verificare attentamente l'equilibrio tra periodi lavorati e periodi trascorsi in pensione."

Il commissario Andor ha aggiunto: "Ci troviamo di fronte a una scelta fra pensionati più poveri, contributi pensionistici più elevati o un maggior numero di persone che lavorano di più e più a lungo. Garantire che la vecchiaia non sia sinonimo di povertà è uno dei grandi successi del modello sociale europeo. Si tratta di una promessa che dobbiamo continuare a mantenere ed il dialogo che avviamo oggi dovrebbe aiutare gli Stati membri a prendere le decisioni giuste per garantire che i sistemi pensionistici siano adeguati allo scopo".

Il Libro verde esamina il quadro pensionistico europeo in modo completo ed integrato, sfruttando le sinergie della politica economica e sociale e della regolamentazione dei mercati finanziari. È per questo che in esso sono trattati numerosi temi, come: il prolungamento della vita attiva, il mercato interno delle pensioni, la mobilità delle pensioni attraverso l'UE, le lacune della normativa UE, il futuro regime di solvibilità per i fondi pensione, il rischio di insolvenza dei datori di lavoro, un processo decisionale informato e la governance a livello dell'Unione.

Esso mira in particolare ad affrontare le seguenti questioni:

- garantire redditi da pensione adeguati e la sostenibilità a lungo termine dei sistemi pensionistici;
- conseguire il giusto equilibrio tra lavoro e pensione e facilitare il prolungamento della vita attiva;

- eliminare gli ostacoli per le persone che lavorano in diversi paesi dell'UE, come pure gli ostacoli al mercato interno dei prodotti pensionistici;
- rendere le pensioni più sicure, nel quadro della recente crisi economica, sia nell'immediato che a lungo termine;
- garantire che le pensioni siano più trasparenti affinché i cittadini possano prendere decisioni informate sui propri redditi da pensione.

La consultazione è un'iniziativa congiunta dei commissari Andor, Barnier (Mercato interno e servizi) e Rehn (Affari economici e monetari) e riguarda sia le politiche economiche e sociali che la regolamentazione del mercato finanziario. Non presenta proposte politiche concrete, ma intende raccogliere opinioni su possibili azioni future a livello europeo.

Il periodo di consultazione durerà quattro mesi (sino al 15 novembre 2010), durante i quali chiunque abbia un interesse per l'argomento può presentare le proprie opinioni su un sito web La vostra voce. La Commissione europea analizzerà poi tutte le risposte ottenute e considererà le migliori linee d'azione per il futuro con cui affrontare queste problematiche a livello UE.

Contesto

Garantire un reddito da pensione adeguato e sostenibile per i cittadini UE è attualmente una priorità per l'Unione e continuerà ad esserlo in futuro. Conseguire questi obiettivi in un'Europa che invecchia costituisce una sfida di rilievo. La maggior parte dei paesi dell'UE ha cercato di prepararsi a questa situazione riformando i propri sistemi pensionistici.

Nel 2008 erano quattro le persone in età lavorativa (15-64 anni) per ogni cittadino UE di 65 anni o più. Entro il 2060 tale rapporto diventerà di due ad uno. La recente crisi economica e finanziaria ha aggravato e amplificato l'impatto di queste tendenze demografiche. Le difficoltà a livello di crescita economica, bilanci pubblici, stabilità finanziaria ed occupazione hanno reso più urgente l'adeguamento delle pratiche di pensionamento e delle modalità di accumulo dei diritti alla pensione. La crisi ha mostrato che occorrono maggiori sforzi per migliorare l'efficienza e la sicurezza dei regimi pensionistici.

Da una recente indagine Eurobarometro è emerso che il 73% dei cittadini dell'Unione si aspetta chiaramente prestazioni pensionistiche ridotte o ritiene di dover posticipare la propria pensione o risparmiare di più per la vecchiaia. SICUREZZA DEI PRODOTTI ALIMENTARI: GLI ESPERTI UE CONFERMANO CHE LA PRODUZIONE LATTIERO-CASEARIA PUÒ RIPRENDERE SOLTANTO QUANDO I PRODOTTI SONO SICURI

La Commissione europea sta monitorando attentamente la situazione della mozzarella contaminata. La produzione di prodotti lattiero-caseari nello stabilimento in Germania da cui è partito il caso della mozzarella blu potrà riprendere soltanto quando ne sarà accertata la sicurezza per il consumo. Questo è il duplice messaggio emerso dalla riunione di ieri degli esperti UE (Stati membri e Commissione) riuniti nel comitato permanente per la catena alimentare e la salute degli animali (SCoFCAH). Le autorità tedesche per la sicurezza dei prodotti alimentari hanno informato dettagliatamente gli altri Stati membri e la Commissione sui controlli effettuati dalle autorità competenti e sulle misure correttive adottate dallo stabilimento.

La Commissione ha presentato al Comitato permanente i risultati principali della missione in loco degli ispettori dell'Ufficio alimentare e veterinario (*Food and Veterinary Office, FVO*), svoltasi tra il 23 e il 25 giugno. Ha evidenziato, fra l'altro, la mancata informazione delle autorità competenti da parte dell'impresa quando la contaminazione è stata individuata. La Commissione ha affermato che soltanto quando le autorità competenti forniranno garanzie complete che la fonte di contaminazione sarà stata eliminata e la qualità batteriologica dei prodotti ristabilita, la produzione dei prodotti lattiero-caseari (come la mozzarella) potrà riprendere.

La mozzarella alterata prodotta nello stabilimento in questione aveva una colorazione blu. L'alterazione è stata segnalata in un primo tempo in Italia, paese che ha notificato il caso il 9 giugno scorso a tutti gli Stati membri dell'UE e alla Commissione tramite il Sistema d'allarme rapido per gli alimenti e i mangimi (RASFF). Il formaggio alterato aveva inoltre raggiunto altri Stati membri e paesi terzi, nei quali il prodotto è stato ritirato dal mercato.






PASSIVE ENERGY EFFICIENCY IN BUILDINGS USING INORGANIC THERMAL INSULATION

CIP-EIP-Eco-Innovation-2008 (CIP-PAE-2008.4.02 - CIP-PAE-2008.4.06)

Abstract, including objectives:

The principal objective of the project is to obtain a thermal envelope for buildings by injecting inorganic thermal and acoustic insulation (TAI) material between the skin of the outer and inner walls that form the thermal-acoustic insulation cavity. This gives an energy saving of 20% compared with traditional techniques, using a new and innovative product that is applied in a continuous process thus avoiding any heat bridging. This product is not based on petroleum (as are the products currently on the market). It is inorganic, recycled materials are used to produce it, it does not damage the environment, is non-combustible and of course thermally and acoustically efficient. And of particular importance for building at the present time, the initial inorganic raw materials are the cheapest on the market, which allows us to offer a price that is highly competitive and efficient for its introduction. Inorganic thermal insulation can achieve a saving of 20% on the average house's energy consumption, so it is one of the most important ways of reducing overall CO₂ emissions at a global level. In addition, thermal insulation accounts for 0.1% of the total cost of building a house and is the only material whose cost is recovered solely by the energy saving it permits. Its great efficiency as both thermal and acoustic insulation is due to its structure, which is similar to an inorganic sponge containing pockets of gas and air, and this enhances its insulating properties. Nueva Tecnología Rehabilitación y Reformas S.L, has researched this process by trying to generate an inorganic foam for thermal and acoustic insulation in order to produce a foam that would have greater capacity as a pore filler, increased thixotropy and greater adhesion when applied, which could be applied at up to double the required thickness, and above all, so that the inorganic foam would form well, not shrink and the gas/air would remain trapped inside it. In addition is is applied using a continuous process that requires practically no labour. Thanks to the great innovation achieved in obtaining an inorganic foam, which no-one has previously achieved with a minimum thickness of application of 5 cm more than satisfactory results are achieved compared with existing insulation materials, and without forgetting that it does not depend on fossil fuels, since none of its compounds derives from them. Its composition includes recycled raw materials of industrial by-products. I wish to make you aware of a unique project “Expedition to the Mars” and forward the invitation to all NEREUS-partners to join this initiative. Please find attached more information on a Czech initiative **“Mars-Expedition”** aimed at attracting pupils and students aged 14-18 years to space and spreading the understanding of space. The project has a long tradition and is under the patronage of MEP Vladimir Remek, a former Czech astronaut. This project in the area of Communication, Education and Training is embedded in the activities of a Czech children radio program and children’s press agency.

All NEREUS-partners are invited to join the initiative. Additionally the idea of this project might have the potential to build with the Czech partners a consortium to mobilize a publicly funded EU-project. In case a NEREUS-member wishes to participate already this year, please contact the secretariat **until latest 15 August 2010**. The pre-selection phase will start in September and the final stage, the simulation of space exploration will be realized in December/January 2011.

“Mars-Expedition” is a game-competition aimed at selecting two teams of students with whom an expedition to the mars is simulated. Until the final two teams are identified the participants go through a number of stages where they are introduced to space relevant fields of activities and get an idea of the different competences and tasks that are necessary to engage in space expeditions. They learn that for flying to the moon or mars you need not only to speak English besides having a solid knowledge of maths and physics but you need also to be a good team player.....

Usually 200 – 300 students participate in the pre-selection questionnaire via the internet. Attached to this letter are some sample questions to give you an idea of what is being asked. Whoever completed the first stage successfully gets admitted to the second level which includes project assignments and testing of basic knowledge. Out of this pool of candidates 30 people get selected to participate in a 2-day-on-campus-competition. This two days event involves different tests, games and team competitions. For more info see description of activity in attachment.

The aim of the in-house competition is to identify the two space crews, each 5 participants, a total of 10 participants for the simulation expedition to the mars. One crew will be put in the air-craft and the other crew is ground based to support the first crew. Both crews go to all stages of the training. Venue for the simulated space flight is usually the Wallonia Space in Belgium. This space center offers a size one to one training facility with a real spaceship and the necessary PC-equipment. During the simulation which takes place for about 3 h one team gets locked into the space shuttle and communicate with the ground based team via computer and radio connection.






The key theme for this year's Conference is "***Understanding Homelessness and Housing Exclusion in the New European Context***". The conference will take place in **Budapest on the 17th September 2010**.

The Theme

Research into dimensions of homelessness and housing exclusion in Europe has been geographically uneven, with more published research emanating from Western and Northern Europe to date. This gap is gradually being addressed, and the aim of this conference is to both stimulate and consolidate research exploring homelessness and housing exclusion in Central and Eastern Europe. We welcome in particular papers that compare dimensions of homelessness and housing exclusion across Central and Eastern Europe, but also wish to encourage the submission of papers that focus on dimensions of homelessness and housing exclusion in individual Central and Eastern European Countries. Although a particular focus of the conference is on understanding homelessness and housing exclusion in Central and Eastern Europe, the conference will also include open sessions on the broad theme of 'homelessness and housing exclusion' from across Europe.

Keynote Speakers

Dr. József Hegedüs is a founding member of Metropolitan Research Institute (MRI), which was established in 1989. Dr. Hegedüs carries out research in housing policy, urban economics and municipal finance. Besides this,

he has been participating in technical assistance projects in transitional countries, and has been working on social housing reforms and social exclusion in Hungary and the region in the last two decades. In 2007, he was a consultant in the work on access to housing for vulnerable groups commissioned by the Council of Europe. More recently, he headed a research team at MRI which completed a research on housing exclusion in relation to the economic crises of 2008.

Bill Edgar is Director of European Housing Research Ltd and an honorary research fellow at the Universities of Dundee and St Andrews. He was the research co-ordinator of FEANTSA's European Observatory on Homelessness from 1998 to 2008. During this time he developed ETHOS – a typology of homelessness and housing exclusion – adopted widely in Europe and recently as far afield as New Zealand. Other publications include Women and Homelessness, Access to Housing and Immigration and Homelessness in Europe. He has co-ordinated a number of EU funded projects including MPHASIS - Mutual Progress on Homelessness Through Advancing and Strengthening Information Systems.
